Use of the information collected and transfer of data with third parties

Limitation of use and disclosure of information - ARCO Rights

Means to Exercise ARCO Rights (access, rectification, cancellation and opposition) In accordance with the Federal Law on Protection of Personal Data in Possession of Private Parties and its Regulations, the owner of the Personal Data, by himself or through a legal representative, must identify himself or properly accredited, you can exercise your rights of access, rectification, cancellation and opposition ("ARCO Rights"), clearly and precisely describing the Personal Data with respect to which you seek to exercise any of the ARCO Rights, which are the following:

- 1. Access.- You may request at any time to know what data of yours has been collected and that is kept by the person in charge, as well as information regarding the conditions and generalities of the treatment
- 2. Rectification.- In the event that any of your data is inaccurate or incomplete, you may request its correction, indicating what data it is, and you must attach the documentation that accredits or supports said modification.
- 3. Cancellation. The cancellation of the data may be requested at any time; If the request is appropriate, a blocking period will begin in which your Personal Data may not be processed in any way for subsequent deletion.
- 4.Opposition.- At any time, the owner may oppose the processing of his Personal Data for legitimate reasons or request that said treatment cease.

Terms and conditions of the Partnership
